Subject: Renewal of Memorandum of Understanding for Sagarmala DDU-GKY convergence programme - reg.

The undersigned is directed to refer to DO dated 19.06.2025 of JS (Skills) on the above subject and to state that being terminal year of the 15th Finance Commission, Ministry is undertaking assessment of the performance of Sagarmala Scherne before approaching Department of Expenditure for its further continuation during the 16th Finance Commission cycle.

- 2. Under this assessment, Ministry has also decided to evaluate the performance of Sagarmala DDU-GKY convergence programme and its ground impact for incorporating the learning for further improvement in the coming days.
- 3. However, due to constraint of fiscal space under Sagarmala scheme and keeping in view the fact that current term of Sagarmala Scheme is also ending on 31st March 2026, MoPSW is not in a position to sanction new projects at present. However, the funds will be released for the training already completed and undergoing by the training partners of Sagarmala DDU-GKY convergence programme.
- 3. The Ministry acknowledges and appreciate the efforts and cooperation extended by MoRD so far and remain open to proactively engaging for future synergies, as and when opportunities arise. Accordingly, the Ministry has decided not to proceed ahead with the MoU on Sagarmala DDU-GKY convergence programme at present.
